## 4. Actions from the previous minutes

### Actions:

- NZSAR will also attempt to obtain student records from TPP
- Fliers for CIMS 4 to be updated by NZSAR
- LandSAR to continue working on the CIMS 3 online course
- SAR training framework, pathway and KPIs to be reviewed again by PAC members and finalised, sent to Alison for final work to be completed

## 5. 2024 SAR Training Calendar planning

Not all agencies were able to bring their training requests to this meeting, therefore the planning will be done out of this meeting.

Coastguard stated they find this process hard because it's really hard to know what training they will be needing for next year.

The possibility of being able to offer refresher training was top of mind for all agencies. Coastguard and SLS stated this is where their biggest need is.

PAC members have requested for it to be noted that the current funding restrictions are not fit for purpose i.e. for skill acquisition only. Is it possible for PAC to explore and redefine what skill acquisition means in the SAR sector.

Coastguard and SLS also stated they aren't really taking on that many new people, not huge numbers. "Refresher training is really important".

It was also noted that if volunteers are not receiving regular refreshers of training, it creates a significant risk when responding to an event.

#### Actions

- Coastguard and SLS stated they could get some training request information to NZSAR by middle of next week (early November 2023)
- NZSAR to collate all training requests from all agencies when they come in
- LandSAR to plan the calendar and submit back to PAC for approval.

## 6. Training provider update

Provided programme tracking report data (see page 2 of LandSAR training provider update document).

Average cancellation rate is 19%, with reasons for cancellation being mainly low or nil registrations.

Still receiving good feedback about the courses being delivered.

Tutor Matrix: 1 person put forward for approval: Gerald Blackburn

Advisory Group Updates: No actions or updates to report.

#### Request to add Lost Person Behaviour to scope:

SLS stated they are getting more requests to help or assist with persons missing due to Alzheimer's and other health reasons. It would be good to have a course using the WanderSearch competencies.

Proposal to add a lost person behaviour course to the scope in 2024 – incorporate as part of Multi-Agency programme – seconded. Governance Group to approve.

#### Minor course update process amendment:

Courses often require minor updates – LandSAR proposed to amend courses out of PAC meetings if they are not major changes and PAC members are notified.

PAC agreed (and seconded) as long as there is a good feedback loop to make comments and changes can be overseen before they are implemented. Also under the proviso that 'minor' is defined. The process can then be taken offline and 'done out of meeting'.

Need to ensure good loopback also to NZSAR to ensure updates are made to materials on NZSAR website.

Minor changes to courses list and further information provided in pages 5-7 in Training Provider update document.

The Managing the Initial Response course material has been reformatted – requires retrospective approval from PAC - seconded

Extended Search Planning course material has also been reformatted – requires retrospective approval from PAC - seconded

#### CIMS 3 delivery delayed because:

1. The SARPAC decision to uncouple CIMS3 from the CIMS4SAR course as it was only the SAR Sector that required this, not NZQA. This has made entry into CIMS4SAR easier. This has meant that time otherwise spent on developing the course has been prioritised into minor updates to existing courses (as above) and management of the existing programme.

LandSAR propose to approve updating the CIMS 4 material to align with other updated CIMS courses - seconded

2. The materials from the multi-agency programme were not 'plug and play' as originally intended and has taken approximately \$40,000 in Land Search and Rescue time to get to the point of being deliverable (see paragraphs above).

3. Currently, the Multi-Agency programme is running at cost-of-sales to maximise output delivery and ensure that all training could go ahead, especially the two SARM in 2023. This means that all management, administrative, and logistical overhead costs associated with the programme, estimated to be an additional \$40,000 have also been absorbed by Land Search and Rescue.

### Actions

- PAC recommends the Governance Group approve the addition of a Lost Person Behaviour course to the scope in 2024 – to be incorporated as part of Multi-Agency programme.
- PAC recommends the Governance Group approve the updating of the CIMS 4 material to align with other updated CIMS courses
- LandSAR to define 'minor' and PAC agree from there
- LandSAR will advise of minor changes out of PAC meetings. Need to ensure all PAC members have read, understand and agree to changes

### Marine SAR Technical course discussion:

Updates have been made to the training materials by a tutor without going through the redevelopment process. The tutor is probably not aware that there is a process to make changes – NZSAR to discuss with him.

There could be some copyright restrictions, but sure if they are legitimate? Needs to be investigated.

Coastguard agreed the course does need to be updated.

## 9. Agenda Item 9. Contingency planning for spending ACE funding

NZSAR advised the PAC that to ensure we don't run in to problems at the end of each year where courses are cancelled or postponed, we need a contingency plan. We need to ensure all of our allocated ACE funding is spent, so we are in a position to ask for more funding in the future.

End of 2023: At present (late October 2023), we look to have around \$30,000 underspend. LandSAR proposed a plan to spend around \$20,000 of this by paying for two 'hybrid' courses (made up of current course components; no new material). These courses will be delivered to volunteers.

PAC discussed a few ideas:

- Potentially not scheduling as many courses in Oct/Nov, as this is where courses seem to be cancelled more.
- Environmental constraints also need to be considered.
- Allan suggested agencies add "**save the date**" **training days** to schedules to have training tentatively booked in to use underspend funds. If the courses are cancelled because rest of calendar is on track, it's easier to do this than try to schedule a course a few weeks in advance.

### Action

- PAC recommend the Governance Group approve the delivery of the 'hybrid' or 'contingency' courses (see additional notes)
- NZSAR and LandSAR will meet earlier in the year to look at the forecast for the rest of the year

## 10. Agenda Item 10. Training pathways & KPIs

PAC were asked to review the training pathways and KPIs that have been created for the sector. These documents have been worked on previously by the group.

As the group haven't convened in a while, more time was asked for to review. The group want to ensure both documents are complete and correct before they are published and made available to the sector

### **11. Agenda Item 11. SAR Managers course redevelopment**

Nathan White gave the group a debrief around the October course.

The course working group are meeting again in early December to go through any changes or recommendations, and changes will be made as necessary.

### 12. 2024 student training survey

NZSAR are about to engage again with the survey provider AK Research to plan for the 2024 survey. The survey will differ slightly as all training is provided by LandSAR now. Aimee is working with the contractor to further define what information we want from the survey.

PAC were asked if there were any changes to be made to the survey – PAC had no changes to offer

#### Action

NZSAR will continue with launch of survey.

### 13. Agenda Item 13. NZSAR update

Aimee advised that aside from her, new to the Secretariat is a Senior Policy Advisor Matt Mintrom.

NZSAR are down two staff members at present and have asked agencies to be mindful of this if work is delayed.
